The roll call was taken by Katerri Johnson, City Clerk, and the following were present:

City Clerk Johnson read the official results from the March 14, 2023 Nonpartisan Election into the record for Commission/Seat #2 and Commission/Seat #4; including all regular, absentee, and provisional votes as ascertained by the Palm Beach County Supervisor of Elections, and that it is hereby declared, based upon the foregoing results, and that Angela D. Burns was elected as Commissioner/Seat #4, and Rob long was elected as Commissioner/Seat #2 for a three-year term commencing on the 30th day of March 2023 and ending in accordance with the charter.
