

Will be doing an analysis to see if the mural design meets design guideline. Damian asked the name of muralist is not yet provided. Tonya questioned the modern design on the outside of the Lodge. Michelle noted that the building is not currently a functioning lodge. Lark asked about who the adjacent neighbors are to the building. Anita comment that the mural is very large. Lark asked about legacy or maintenance plan

for the mural. Lark – how is this connected to the community. Michelle noted that it is the Masonic connection. Damian explained how he thinks that this will be an exciting addition to the area. Lark asked about historic preservation and how this zoning in progress will happen and include the historic preservation regulations.
