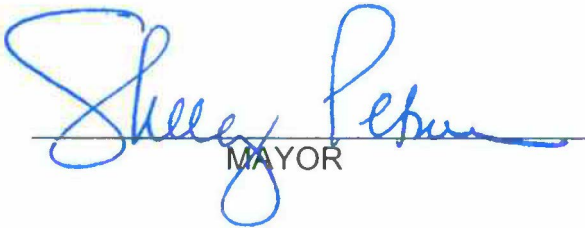
The Shade meeting went into recess at 9:25 a.m.    All attendees
