VII. STATE OF EDUCATION DISCUSSION:

While the Board had created a strategic plan over the past year to implement this year, COVID-19 requires a new discussion. While we were working on making measurable progress we are in a new era of "Covid-19 slide" and "learning loss recovery" mode. The needs to shift its focus based on the what th new information and data is telling us.

Enrollment is down in our public Schools. There is a total of 6710 students that are attending a Delray Beach Public School and of that number 4037 students live in municipal boundaries. This is approximately 400 less students enrolled from last year. Of the 4037 students living in the boundaries 3649 or 90% are on the Free and Reduced lunch program and 1428 or 35% are not connected to the internet or live in an area of the city that has reliable internet connectivity. The School Districts web site provided the following attendance of students that had logged on for distance learning as of the September 14th (2 weeks after school started.

The Board also discussed data that the National Campaign for Grade Level Reading Learning Loss Recovery information and if children did not have in-class instruction before January 2021:

HOW BAD WILL IT BE?

In June 2020, McKinsey & Company estimated that, if in-class instruction does not resume until January 2021:

- All students will lose ground 3–4 months if they receive average-quality remote instruction, 7–11 months if they receive lower-quality instruction and 12–14 months if they receive no instruction.
- Low-income students will lose the most more than 12 months.
- Children of color will lose more learning than white children. Black students are likely to lose 10.3 months and Hispanic students 9.2 months. McKinsey estimates that these losses will exacerbate existing achievement gaps by 15–20%.

The Board had a short discussion regarding the information presented. It was discussed that approximately 50% of the students would be coming back to campus – bricks and mortar. The school day is a "belled schedule" meaning it's a full school day. There are issues with connectivity, but distance

learning will continue with in-class learning as well. The Board discussed the need to focus on 2-3 strategies to help with learning loss recovery that are attainable and should be presented to the City Commission at some time in the near future. Ideas included better branding and marketing, internet connection, pod learning, community involvement and working closer with the Chamber of Commerce. The Board determined that they would continue their discussion on specific strategies at the next meeting and would individually do some research on their own.
