Sandra Cordova, Assistant Human Resources Generalist, presented the Next Generation Initiative. She highlighted the city's youth development programs including Shadow Day, internship programs, and volunteering opportunities. Ms. Cordova shared that the city is in the process of implementing a technical apprenticeship program to help prepare students for the workforce within technical fields.

> Ezra Krieg, Chairperson of the Delray Beach Initiative to End Homelessness, presented a timeline on the task force's progress, challenges, programs, and goals. He explained that being homeless was a circumstance and not related to a specific behavior. Mr. Krieg complimented the Police Department for their continued partnership and for treating homeless residents with dignity. He shared that there are more than twenty community partners and eleven interfaith groups who are working to end homelessness within the city and are providing services such as establishing a shower truck location, implementing laundry services, creating a reading program, providing bus passes, counting the homeless population, providing vaccinations, and creating programs to feed children and their families.

> The Commission thanked Mr. Krieg and the Police Department for their continued efforts. The Commissioners were proud to see the City of Delray Beach as a leader in ending homelessness and were setting an example for other cities to follow.

B. From the Public

Emelie Konopka, Chairperson of Old School Square, residing at 12990 Blue Lane Drive, Wellington, spoke about her service to Old School Square. She provided updates on the organization's progress and shared that the Crest Theater would reopen in the fall. Ms. Konopka invited the Commissioners to visit and to get involved with Old School Square.

Mayor Petrolia concluded public comments.

#### 6. CONSENT AGENDA: City Manager Recommends Approval

Deputy Vice Mayor Frankel made a motion to approve the Consent Agenda as amended. It was seconded by Commissioner Casale. The motion carried by the following vote:

**YES 4** - Mayor Petrolia, Vice Mayor Johnson, Deputy Vice Mayor Frankel, and Commissioner Casale.

#### Item 7.A.A.

Mayor Petrolia informed the Commission that she had received numerous concerns about the safety of the city's buildings.

Commissioner Casale and Vice Mayor Johnson inquired about the city's authority to inspect buildings.

Lynn Gelin, City Attorney, informed the commission that unsafe structures are included in the city's code of ordinances. If there is an anonymous complaint the Code Enforcement Division can inspect the property. If the building is found unsafe there are provisions that the city can take including condemning the structure. The city will work to ensure that its residents are in safe and habitable homes.

Vice Mayor Johnson inquired about a reported unsafe structure in the community. She recommended creating a list of buildings documenting their height and age.

Sammie Walthour, Interim Director of Neighborhood and Community Services, explained that the complaint was received in early June. He informed the Commission that the Building Official and Code Enforcement responded to the situation and that once the building was deemed unsafe the Homeowners Association (HOA) had to take precautions to ensure the safety of the building with evidence from an engineer. Mr. Walthour reported that construction began and that the issue was resolved within three weeks.

Jennifer Alvarez, Interim City Manager, noted that the Florida Building Code does not grant the city unilateral authority to inspect a property; the city would only send code enforcement when there was a concern or complaint. Ms. Alvarez informed the Commission that the city was working closely with the League of Cities and Palm Beach County regarding this issue. She reported that the city was compiling a list of older buildings and sending them letters reminding the HOA that it was their responsibility to obtain an inspection report from a structural engineer. Additionally, she shared that three of Delray Beach's Fire Rescue Officers were assisting with the emergency search and rescue in Surfside.

Keith Tomey, Fire Chief, confirmed that the city would be reimbursed 100 percent through FEMA for the officers who have gone to Surfside. He assured the Commission that the firefighters have respiratory protection on sight.

Mayor Petrolia asked Ms. Alvarez to keep the Commission apprised of the League of Cities findings.

Ms. Barletto added there had not been a rate increase in several years.

<u>Lisa Quillian</u>, residing at 925 SE 2nd Avenue, Delray Beach, expressed that nothing moved forward since her conversation with the Commission last year. Ms. Quillian voiced concern that the developers are in favor of this project and not the residents.

<u>Bill Morris</u>, residing at 777 E Atlantic Avenue, Delray Beach, Owner of Worthing Place, believed that Osceola Park was an excellent opportunity for the city to mix Market Place Housing with Workforce Housing.

Ken Ropp, 217 SE 3rd Avenue, Delray Beach, expressed concern about

how the traffic would increase near SE 4th Avenue. He inquired if a traffic study had been conducted. Mr. Ropp proposed listening to what the residents envision for their neighborhood before moving forward.

<u>Gary Wulf</u>, 831 SE 4th Avenue, Delray Beach, voiced his concerns regarding the dog kennel near his house and asked the city to act.

boards in the future. Mayor Petrolia congratulated the Parks and Recreation Department on their successful Independence Day firework displays.
