#### 4.E. INTERNAL AUDIT PRESENTATION

Dr. Julia Davidyan, City Auditor, discussed the audit conducted for Old School Square. She concluded that Old School Square did not comply with Article 6.1. of the lease they entered into on December 1, 2016. Dr. Davidyan noted that in the appendix of her report, she provided recommendations to enhance record-keeping and reporting transparency. Dr. Davidyan provided a slide presentation on the complete audit results.

Commissioner Casale confirmed that Dr. Davidyan reached out to the Community Redevelopment Agency (CRA) for documents even after Old School Square seized their communication with the City on September 11, 2021.

Mr. Moore, City Manager, informed the Commission that he visited the Arts Garage Facility earlier and met with Ms. Waldo to understand the scope of their agreement. Mr. Moore shared of his positive experience and impression with what he had seen.

Dr. Davidyan informed the Commission that Old School Square's annual budget files were primarily geared to the CRA and based on the financial forms she received, they were not in compliance.

Finally, Dr. Davidyan concluded that on the basis of the financial forms not submitted to the City as requested, Old School Square was not in compliance.

Deputy Vice Mayor Frankel inquired if other non-profits had as astringent reporting requirements as Old School Square.

Lynn Gelin, City Attorney, explained smaller non-profits do not have strict reporting

requirements because their budgets cannot support a full-blown audit nor do they receive taxpayer funding that Old School Square receives.

Mayor Petrolia reminded the Commission that Old School Square is welcome to re-apply when the contract goes out for RFP.

Mr. John Lege, Finance Director, highlighted the changes made since August 24, 2021, Budget Workshop. He reported on the following changes for the 2021-22 Proposed Budget.

- ➤ Increase in Proposed Budget: 9.06 % from 2021 Fiscal Year Budget.
- ➤ Increase in General Fund Revenue: \$118,443.
- ➤ Increase in General Fund Expenditures: \$118,443.

As Commission requested, Mr. Lege transferred \$200,000 from the Tree Planting Fund to the Special Projects Fund.

He added that staff recommended using \$4,604,502 in American Rescue Plan Act (ARPA) Funds to close the budget gap in the General Fund for Fiscal Year 2021.

He explained how the funds were appropriated in Resolution No's 139-21, 140-21 and 141-21.

Mr. Moore remarked that Mr. Lege's presentation covered agenda Item No's 8.A., 8.B., and 8.C.

There were no public comments pertaining to Items 8.A, 8.B, or 8.C.

Vice Mayor Johnson inquired about the error of how reimbursements were being calculated as discussed at the League of Cities Board Meeting. Mr. Moore assured Commission that the City of Delray Beach was not affected.

Commissioner Boylston motioned to approve Resolution No. 139-21 to set the millage rate at 6.6611, the debt service rate at 0.1792, and the overall millage rate at 6.8403. It was seconded by Commissioner Casale. The motion was carried by the following vote:
