Mr. Kanthan provided the Commission with a video of the “Throw Social” experience. He reported he is seeking permission to add “Throw Social” to the back of Il Bacio Restaurant.

Mr. Flesher reported that “Throw Social” is located in other states and follows stringent safety precautions.

Ms. Gianniotis, Director of Development Services, noted that “Throw Social” was consistent with the Comprehensive Plan Policies. She verified that granting conditional use would not affect neighborhood stability or hinder the development of nearby properties. Ms. Gianniotis advised the Commission that the Downtown Development Authority and the Planning and Zoning Board voted to support the Conditional Use for the Commercial Recreational Facility.

Laura Simon, Executive Director of the Downtown Development Authority, recognized that the Downtown Development Authority approved bringing “Throw Social” to Delray Beach.

Mayor Petrolia closed public comments pertaining to this item.

There was no cross- examination or rebuttal from the applicant.

C. City Commission:

Deputy Vice Mayor Frankel inquired when the construction on Swinton Avenue improvements would be completed.

Vice Mayor Johnson reported that she attended the public meeting for the Pompey Park Project. She commended Mr. Metott from Parks and Recreation and informed everyone that they had hired a new architectural firm. Ms. Rene Jadusingh, Executive Director of the CRA, reassured the public that there is secure funding and that the Pompey Park Project would be completed by 2024.

Vice Mayor Johnson further emphasized her gratitude for all of the staff's hard work in preparing the budget.

Mr. Samuel Metott, Director of Parks and Recreation mentioned a website would be dedicated to Pompey Park named, Pompey Park Project.com where residents can submit their thoughts and ideas.


