### A. Chief Javaro Sims Update:

Members of the board were provided with Part 1 Crime Statistics for 2021, which revealed a decrease of 14.32% from the previous year.

A total of 62 overdoses were reported for this year and three overdose deaths.

The virtual citizen police academy previously scheduled was cancelled due to lack of participation.

The pickpocketing incidents and thefts of cell phones in the downtown area continue but several arrests have been made. The agency also conducted a joint operation with Bureau of Alcohol, Tobacco and Firearms for underage alcohol sale in the downtown area. Discussion ensued regarding auto burglaries incidents and removing valuables from vehicles. Residents continue to be educated by our department on locking their vehicles through social media networks.

A truck was purchased through Delray Citizens for Delray Police for the agency which will be deployed during events to increase community engagement.

## 8. DISCUSSION CONCERNING NEXT MEETING AGENDA:

Next meeting is scheduled for Monday, June 14, 2021. A determination will be made during the month of June if board meetings will resume in-person following Covid-19 guidelines set forth by the CDC and the City of Delray Beach.
