The Workshop Meeting was called to order at 3:30 p.m.

The roll call was taken by Katerri Johnson, City Clerk, and the following were present:

Present 5: Mayor Shelly Petrolia, Vice Mayor Adam Frankel, Deputy Vice Mayor Juli Casale, Commissioner Ryan Boylston, Commissioner Shirley Ervin Johnson

Others present were: Terrence Moore, City Manager Lynn Gelin, City Attorney Natalie Sherry Emma Sherry

Mr. Moore advised that this item was brought before the Commission for consideration. Representatives from the company were available for any specific questions or concerns the Commission had.

Attorney Gelin established protocol as it relates to an opinion Vice-Mayor Frankel requested due to a possible conflict of interest. She added, as per F.S. 112.313(12)(j), Vice-Mayor Frankel was able to participate in this matter and did not have to withdraw from his seat.

The company's representative began by clarifying the corporation's name. He stated the LDR is being asked for Mango Cottage Delray LLC, which is the building's holding company, and the Cart Shop is the name of the actual business.

He continued and pointed out the carts they rent are called carts but are

legally classified as low speed vehicles (LSV) and they were made to be street legal. He briefly spoke about the safety of the LSVs. He then stated their building is within one block of the Central Business Distric (CBD) and the current zoning language for the CBD allows for their type of business. He expressed the conflict in the general commercial (GC) zoning language because it currently reads "Neighborhood electric vehicles, lease or sale rental transactions can occur but you cannot have inventory on site." He asked how someone can sell, rent or lease without keeping the inventory onsite and noted they have a 3000 square feet building and can keep everything indoors.

He explained the LSVs are all electric; no gas, no oil, no chemicals, and they are completely quiet. He concluded by stating they are asking for the zoning language to be revised so their inventory can be stored on site.

Development Services Director, Anthea Gianniotes, spoke about the section of the code referenced and asked for direction from the Commission.

Some members of the Commission expressed concerns that the carts may become a bigger issue in the future.

Attorney Gelin stated the representative only needed one Commissioner's sponsorship based on the old policy. She informed the representative that they can submit an application and recommended taking the comments of the Commission into consideration because if the item goes forward, three affirmative votes will be needed. She added the business was not approved to keep the inventory on site.

With no further business to discuss, the Workshop Meeting was adjourned at 3:29 P.M.
