WS.1. DELRAY BEACH MUNICIPAL GOLF COURSE PUBLIC PRIVATE PARTNER SELECTION PROCESS

Ms. Sara Maxfield, Economic Development Director, introduced Lee Ann Korst, First Vice President, Southeast Regional Manager of CBRE, who has been hired as a consultant to facilitate the redevelopment of Delray Beach Golf Club.

Mr. Richard Singer, of the National Golf Foundation, spoke about the golf course, current trends and conditions.

Mr. Chris Smiles, Real Estate Broker, Senior Vice President at CBRE, spoke about the strengths of the golf course property in the current real estate market.

Max Abala, of Gridics, discussed the possibilities and potential plan for a commercial development, on a conceptual level.

Ms. Korst reviewed the timeline for the project, the Request For Proposal (RFP), marketing, bids, and procurement processes. Once analysis is completed, the results will be brought to the Commission, at the end of this year or beginning of next year, for their review and selection.

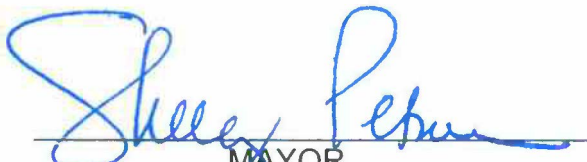
Further discussion ensued.
