Below are highlights of significant activities that occurred during the month of July:

- 1. Areawide & Neighborhood Plans- Dr. Rev Thomas Park Playground (G/L #5366)-**
  - Payments totaling of \$121,124.53 were made payable to Rep Services, Inc for the playground equipment.
- 2. Areawide & Neighborhood Plans- N.W. Neighborhood Design (CIP) (G/L #5622)-**
  - Payment of \$1,600,000.00 was made payable to the City of Delray Beach for the N.W. Neighborhood Improvements.
- 3. Affordable/ Workforce Housing Projects- Support for Affordable Housing Initiatives (G/L #6512)-**
  - Payments totaling \$507,600.00 were made payable to Delray Beach Community Land Trust, Inc. for the project at 246 N.W. 8<sup>th</sup> Avenue.
- 4. Community Improvement & Economic Development - Clean & Safe (G/L #7332) -**
  - Payments totaling \$753,252.22 were made payable to the City of Delray Beach for funding the Clean & Safe Program for the 3<sup>rd</sup> Quarter of the fiscal year.
