Background:

This Resolution maintains the City’s invocation of the pending ordinance doctrine as applied to dockless mobility devices. City staff will continue to defer its processing of applications for operations

related to dockless mobility devices for an additional 180 days. Staff has been reviewing the subject matter and potential Code changes related to same and expects to have an ordinance for the Commission's consideration in the near future.
