**Background:**

On September 28, 2017, the CRA awarded the Delray Beach Historical Society a \$75,000 A-GUIDE grant plus \$50,000 (to replace funding typically received from the City) for a total funding of \$125,000 which represents 45% of DBHS's program budget. The A-Guide grant was awarded to support the Delray Beach Historical Society's Cultural Heritage and Museum Program. Below are highlights and a program snapshot from the DBHS's 4Q FY 2017-18 A-Guide Report ending September 30, 2018.
