NOMINATION FOR APPOINTMENT TO THE PARKING MANAGEMENT ADVISORY BOARD

**Recommended Action:**

Motion to approve the nomination for an appointment for two (2) regular members to serve on the Parking Management Advisory Board for a two (2) year term ending July 31, 2024.

**Background:**

The terms for regular members Ms. Brenda Cullinan and Mr. Richard Burgess will expire on July 31, 2022. Ms. Brenda Cullinan has served one (1) full term, is eligible and would like to be nominated for reappointment. Mr. Richard Burgess has served one (1) full term, is eligible and would like to be nominated for reappointment. Nomination for an appointment is needed for two (2) regular members to serve a two (2) year term ending July 31, 2024.

The Parking Management Advisory Board was established by Resolution No. 88-97 on December 9, 1997. The purpose of the Board is to advise and provide recommendations to the City Commission regarding parking management policy and related issues. This includes but is not limited to the planning, financing, development, construction, and operation of parking facilities within the boundaries of the Transportation Concurrency Exception Area (TCEA), as well as, all public parking areas located along State Road A-1-A within the corporate limits of the City.
