APPROVAL OF RESOLUTION NO. 14-22 TO AWARD AN AGREEMENT WITH GRANICUS, LLC FOR AGENDA MANAGEMENT AND WEBSITE HOSTING SERVICES UTILIZING REGION 14 EDUCATION SERVICE CENTER, ON BEHALF OF THE NATIONAL COOPERATIVE PURCHASING ALLIANCE (NCPA) SOLICITATION NO. 39-20 IN THE AMOUNT OF \$45,232 FOR AN INITIAL RENEWAL TERM OF DECEMBER 19, 2021 - JANUARY 15, 2023.

Recommended Action:

Motion to approve Resolution No. 14-22 and to award an Agreement with Granicus, LLC for Agenda Management and Website Hosting Services utilizing Region 14 Education Service Center, on behalf of the National Cooperative Purchasing Alliance (NCPA) Solicitation No. 39-20 in the amount of \$45,232 and authorize the City Manager to exercise renewal options, in the amounts below, contingent upon appropriation of funds.

Background:

The Region 14 Education Service Center, on behalf of the National Cooperative Purchasing Alliance (NCPA) entered into a three-year agreement with Granicus, LLC for Agenda Management and Website Hosting Services effective December 8, 2020, through December 31, 2023, with the option to renew for two (2) additional one-year terms; pursuant to Solicitation No. 39-20.

The City had an agreement with a third-party vendor, Carahsoft Technology Corp., for agenda management and website hosting services which expired on December 19, 2021. While we worked to consolidate separate agreements with the same provider on February 16, 2022, under the

authority of the City Manager, the City issued a purchase order in the amount of \$31,500 to ensure no disruption receiving agenda management and website hosting services. Granicus provides cloud-based solutions for communications, meeting and agenda management, and digital services to more than 4,000 public sector organizations. The City now automates its Meeting and Agenda Process rather than using traditional methods, including paper agendas, long approval timelines and lots of extra staff hours. Legistar eliminates manual workloads, authorizes customization of approval sequences, allows City Staff to boost transparency by pushing agenda to the City's web page and permits video streaming of City meetings.

Should the City exercise the renewal options provided in the contract, the cumulative contract value is provided below.
