INTERLOCAL AGREEMENT BETWEEN THE CITY OF DELRAY BEACH AND DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY TO BE A CO-TITLE SPONSOR ALONG WITH THE OF THE 2021 DELRAY BEACH OPEN TENNIS TOURNAMENT

Recommended Action:

Approve the attached Interlocal Agreement between the City of Delray Beach (“City”) and the Delray Beach Community Redevelopment Agency (“CRA”) for the CRA to be a co-title sponsor along with the City of the 2021 Delray Beach Open Tennis Tournament, in an amount not to exceed \$905,000.

Background:

At the September 29, 2020 CRA Board meeting, the Board approved the Fiscal Year 2020-2021 Budget. It included the CRA co-title sponsorship with the City for the 2021 Delray Beach Open tournament at the Municipal Tennis Center in an amount not to exceed \$905,000 taking place February 12-21, 2021. The CRA has provided the following sponsorship funds in prior years as follows:

The sponsorship of tournaments at the Municipal Tennis Center helps further the CRA mission by helping the Tennis Center remain a competitive venue for major events. These events draw thousands of visitors to downtown Delray Beach including the West Atlantic Avenue area, and results in tangible economic benefits for downtown merchants.
