Item A.: Delray Park Plaza South

Request: Consideration of Class I Site Plan Modification to allow for the removal of two roof-top decorative domes and windows.

Request: Consideration of Class I Site Plan Modification to allow for the addition of two awnings.

Request: Consideration of a Class IV Site Plan Modification to allow for the demolition of an existing

bank to allow for the construction of a new 2,564 square foot restaurant, 390 square feet of outdoor dining, and a drive-thru.

Item E.: 912 Palm Trail

Request: Consideration of a color change.

Board Action: Approved on a 3-1 vote (Andreka Youngblood, Carol Perez and John Brewer Absent; Dana Post Adler dissenting).

Item F.: Delray Park Plaza North

Request: Consideration of a Class V Site Plan application to allow for the demolition of an existing 1,823 square foot bar/lounge to allow for the construction of a new one-story 4,995 square foot commercial retail building with four bays.

PCN: 12-43-46-09-11-005-0010

Board Action: Approved on a 4-0 vote with conditions to provide a replacement wall, relocate an existing opaque fence, and a row of 5-gallon Clusia plants (in lieu of the 3 gallon plants proposed) on the inside of the fence.
