Law enforcement agencies and Inspector Generals in Florida can attain accredited status through the Commission for Florida Law Enforcement Accreditation, Inc.

The Commission for Florida Law Enforcement Accreditation, Inc. recognizes there are dedicated individuals and committees that go above and beyond expectations or have developed innovative ways of doing business that deserve special recognition through the Commission for Florida Law Enforcement Accreditation, Inc. awards program.
