Recommended Action:

Motion to Approve purchase awards to Duval Ford, LLC and Hub City Ford-Mercury, Inc., for the purchase of 2 additional vehicles for a total of \$68,514, utilizing Florida Sheriff's Association Contract #FSA16-VEL24.0.

Background:

On October 1, 2016, the Florida Sheriff's Association awarded Contract #FSA16-VEH24.0 for vehicles. The contract is valid through September 30, 2017. Duval Ford, LLC and Hub City Ford-Mercury, Inc. are authorized Ford dealerships. Both dealerships honor the Florida Sheriff's Association contract pricing.

The Environmental Services Department, Fleet Division is requesting approval to purchase 2 vehicles from these two dealerships to be added to the City fleet in Fiscal Year 2017 as replacements for total loss vehicles.

Duval Ford, LLC and Hub City Ford-Mercury, Inc. have certified that the prices offered are the lowest to any other governmental entity within the State of Florida.
