### Background:

The CRA awarded the Delray Beach Historical Society (DBHS) a \$125,000 A-GUIDE grant for FY 2018-2019. This award represents 58% of DBHS's \$214,300 budget. As of the end of the year, the DBHS raised revenue of \$225,460 and had a net income of \$66,659.
