EXPANDING AND PRESERVING OUR CULTURE AND HERITAGE 4TH QUARTER AND YEAR-END FY 2018-19 A-GUIDE REPORT

Background:

The CRA awarded the Expanding and Preserving Our Culture and Heritage, Inc. (EPOCH) a \$111,000 A-GUIDE grant for FY 2018-2019. This award represents 60% of EPOCH’s \$185,185 budget. As of the end of the year, EPOCH raised revenue of \$271,935 and had a deficit of (\$9,603).

The A-GUIDE grant was awarded to support Museum Programming. Below are highlights and program snapshots along with year-end totals from the EPOCH’s fourth quarter FY 2018-2019 A-GUIDE report as of September 30, 2019.
