APPROVAL OF RESOLUTION NO. 24 -20 TO APPROVE AN AGREEMENT WITH RIC-MAN CONSTRUCTION, INC. FOR SW 4^{TH} STREET, SW 6^{TH} STREET, S.W. 7^{TH} AVENUE, AND S.W. 3^{RD} COURT NEIGHBORHOOD IMPROVEMENTS PURSUANT TO ITBC NO. 2019-048 (PROJECT NO. 17-108) - \$5,648,785

Recommended Action:

Motion to Approve Resolution No. 24-20 to award an Agreement with Ric-Man Construction, Inc. for SW 4th St, SW 6th St, SW 7th Ave and SW 3rd Ct Neighborhood Improvements project pursuant to ITBC No. 2019-048 (Project No. 17-108) - \$5,648,785.

Background:

The City of Delray Beach (City) has a Neighborhood Improvement Project at SW 4th St, SW 6th St, SW 7th Ave and SW 3rd Ct. This project includes improvements to the infrastructure and safety of the neighborhood, including water, sewer, reclaimed water, drainage, sidewalks and street lighting. The project is being funded through the Delray Beach Community Redevelopment Agency (CRA).

The City issued Invitation to Bid Construction (ITBC) No. 2019-048 to acquire a firm which will provide all labor, materials, tools, equipment and services related to the construction of reclaimed water system improvements, water main improvements, drainage improvements, sanitary sewer improvements, roadway reconstruction and restoration, lighting improvements and lighting and

irrigation improvements for the SW 4th Street, SW 6th Street, SW 7th Avenue and SW 3rd Court neighborhood improvements project.

On October 4, 2019, the City received twelve (12) submittals pursuant to ITBC No. 2019-048. The low bid submitted by Ric-Man Construction, Inc. was deemed responsive and responsible to the Bid requirements.

Therefore, staff recommends award of the bid to Ric-Man Construction, Inc. in the estimated amount of \$5,648,785. Construction is expected to be substantially completed within 320 days from the date of the City's Notice to Proceed, barring typical construction delay, such as those forced by inclement weather, and completed and ready for final payment no later than 45 days after substantial completion is accepted by the City.
