ORDINANCE NO. 30-20: AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, BY AMENDING CHAPTER 34, "ELECTIONS"; SECTION 34.01, "STATE LAWS TO GOVERN" OF THE CODE OF ORDINANCES OF THE CITY OF DELRAY BEACH, FLORIDA, BY REPEALING SECTION (B) IN ITS ENTIRETY; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES. Recommended Action:

Background:

At its workshop on June 9, 2020, the City Commission directed the City Attorney to draft an ordinance to allow the City to participate in early voting. Currently, Section 34.01 of the Code of Ordinances, expressly "opts out" of early voting. This amendment will allow the City to participate in early voting subject to the guidelines provided by the Supervisor of Elections.
