## FY 2020-2021 CRA A-GUIDE FUNDING REQUEST - DELRAY BEACH PUBLIC LIBRARY ASSOCIATION

### Recommended Action:

Direct staff to include funding for the Delray Beach Public Library in the CRA's FY 2020-2021 Budget in the amount of \$443,000.

### Background:

The Library applied for CRA A-G.U.I.D.E.: Achieving Goals Using Impact Driven Evaluation Funding for FY 2020-2021 under the category of Economic Development and Recreation and Cultural Facilities. Funding is requested for two programs: (Program "A"), which is the Library's Sunday & Monday Operations and (Program "B"), which is the Technology, Training, and Innovation Lab Services. The specifics of the request are summarized below.

This year’s Funding Evaluation Committee consisted of CRA Executive Director, Renee Jadusingh, Finance and Operations Director, Lori Hayward, and Arts Warehouse Manager, Grace Gdaniec. The Committee rated the application package based on the established A-GUIDE criteria. Criteria used in review of the application were grouped into six categories weighted to total 100% as follows:

Organization Capacity	20%
Need for Project/Program	20%
Project/Program Description	10%
Logic Model	20%
Evaluation Plan	10%
Budget & Sustainability	20%

The Application Evaluation Form has six categories and the majority of the items are rated on a scale of 1 to 5 (worst to best possible response) with the exception of two items: *Organizational Capacity - Demonstrated experience/success with similar programs/project* rated on a scale of 1 to 15 (worst to best possible response); and *Logic Model/Projected Results - Stated program/project goal clear and relevant to CRA Overall Need* rated on a scale of 1 to 10 (worst to best possible response).

Please review the attached Application Evaluation Form (Exhibit A) that includes the rating of the committee members on each Project/Program. The outcome of the committee’s review is as follows:

**Total Average Evaluation Score: 88%**

**Program “A”: CRA Sundays & Mondays and Technology, Training, and Innovation Lab**

Evaluation Score: 89%

**Program “B”: Technology, Training, and Innovation Lab**

Evaluation Score: 87%

**A-GUIDE Evaluation Committee Comments & Suggestions:**

The committee recommends funding of \$443,000 with no increase. The committee also expressed concerns that **65%** of the Library’s proposed budgeted revenue (\$2,305,856) is generated by the City of Delray Beach and the CRA. The committee recommends that as a 501(c)(3), the Library should pursue additional funding sources and not be as dependent on local government entities.

As stipulated in the A-G.U.I.D.E. guidelines, the Funding Evaluation Committee reviews each application according to established criteria and makes preliminary funding recommendations to the CRA Board of

Commissioners. Then the CRA Board considers and makes final decisions regarding the funding request. At this time, the Funding Evaluation Committee recommends funding the Delray Beach Public Library Association for fiscal year 2020-2021 in the amount of \$443,000 (\$418,000 to Program A and \$25,000 to Program B).
