### **Background:**

Pursuant to the consensus of the City Commission at the May 3, 2022 Regular Commission meeting directing staff to draft a resolution opposing SB 620 allowing business damages to be assessed against counties and municipalities, staff prepared Resolution 77-22 for the Commission's review and approval. Resolution 77-22 urges Governor DeSantis to veto SB 620, also known as the "Local Business Protection Act." If passed, SB 620 would permit businesses to sue local governments that enact ordinances that cause loss of profits.
