APPROVAL OF AMENDMENT 3 RETROACTIVELY APPROVING CONTRACT RENEWAL WITH T2 SYSTEMS, INC. FOR MULTI-SPACE SMART PARKING METERS AND REDUCING RENEWAL AMOUNTS

Recommended Action:

Motion to approve Amendment 3, for retroactive contract renewal with T2 Systems, Inc. for multispace parking meters, and authorize the City Manager to approve renewal options, in the amounts below, contingent upon appropriation of funds.

Background:

On December 6, 2016, the City of Delray Beach (City) entered into an agreement with T2 Systems, Inc. (T2 Systems) for equipment and services related to multi-space smart parking meters (Agreement) in the amount of \$600,000. Since then, the growing need for additional parking meters as part of the City parking program expansion has resulted in the City Commission approving two amendments for increases for a total agreement value of \$754,080. Moving forward, the annual renewal option is being reduced as the initial purchase of new technology is complete.

This project to implement new parking meters is to provide the City's neighbors, tourists and patrons with the latest state-of-the art technology in multi-space parking meters (meters) to enhance the overall parking experience. The implementation of these meters allows motorists to pay by cash or credit card at the meter or via mobile application. Most of the City's previous meters only accepted coins and time extensions could only be done at the meter.

This motion is in accordance with the City Code of Ordinances, Section 36 and City Policies and Procedures, Change Orders and Amendments.

Should the City exercise all renewal options provided in the agreement, the cumulative value is provided below.
