<u>Item A.</u>: Delray Park Plaza South <u>Request:</u> Consideration of Class I Site Plan Modification to allow for the removal of two roof-top decorative domes and windows. <u>PCN</u>: 12-43-46-09-12-000-0050 <u>Board Action</u>: Approved on a 4-0 vote.

<u>Item B.</u>: Ramen Lab Eatery <u>Request:</u> Consideration of Class I Site Plan Modification to allow for the addition of two awnings. <u>PCN</u>: 12-43-46-16-C8-000-0000 <u>Board Action</u>: Approved on a 4-0 vote

<u>Item C.</u>: 258 SE 6th Avenue <u>Request:</u> Consideration of a color change. <u>PCN</u>: 12-43-46-16-01-111-0250 <u>Board Action</u>: Approved on a 4-0 vote.

<u>Item E.</u>: 912 Palm Trail <u>Request:</u> Consideration of a color change. <u>PCN</u>: 12-43-46-09-A2-000-0010 (0040), (0020), (0030), (0050), (0060), (0090), (0070), (0080) (0100) <u>Board Action</u>: Approved on a 3-1 vote (Andreka Youngblood, Carol Perez and John Brewer Absent; Dana Post Adler dissenting).

Item F.: Delray Park Plaza North

<u>Request:</u> Consideration of a Class V Site Plan application to allow for the demolition of an existing 1,823 square foot bar/lounge to allow for the construction of a new one-story 4,995 square foot commercial retail building with four bays.

<u>Board Action</u>: Approved on a 4-0 vote with conditions to provide a replacement wall, relocate an existing opaque fence, and a row of 5-gallon Clusia plants (in lieu of the 3 gallon plants proposed) on the inside of the fence.
